Privacy Policy of the Lavicon LLC website

This Privacy Policy of Personal Data (hereinafter referred to as the Policy confidentiality) is an integral part of the Public Offer posted on the Internet at: <https://lavicon.ru/> (hereinafter referred to as the Website).

Website Services are interactive (dialog) software components on Website pages that are used to integrate with information systems and provide Website users with certain opportunities to access information on the Website, namely: <https://lavicon.ru/> (hereinafter referred to as the Site's Services).

The use of the Site's services means the User's unconditional consent to this Policy and the conditions for processing his personal information specified therein; in case of disagreement with these conditions, the User must refrain from using the services. Depersonalization of personal data is an action that makes it impossible to determine whether personal data belongs to a specific personal data subject without using additional information.

1. GENERAL PROVISIONS

1.1. Within the framework of this Policy, the User's personal information is understood as:

1.1.1. Personal information that the User provides about himself /herself during registration (account creation) or in the process of using Services, including the User's personal data. Required to provide This information is marked in a special way.

1.1.2. Data that is automatically transmitted to the Site's services during their use using the software installed on the User's device. security information, including IP address, cookie data, browser information The User (or any other program that provides access to the services), the technical characteristics of the hardware and software used by the User, the date and time of access to the services, the addresses of the requested pages, and other similar information.

1.1.3. This Privacy Policy applies only to the Website <https://lavicon.ru/>. Website <https://lavicon.ru/> does not control and is not responsible for third-party sites to which the User can click on links available on the website <https://lavicon.ru/>.

2. PURPOSES OF PERSONAL INFORMATION PROCESSING USERS

2.1. The Website collects and stores only the personal information that is necessary for the provision of services or the execution of agreements and contracts with By the User, except in cases where the legislation provides for the mandatory storage of personal information for a period specified by law. In case of receiving a notification from the User about the withdrawal of consent to the processing of personal data, the Site stops processing the User's personal data in a period not exceeding 10 business days from the date of receipt. The notification of withdrawal of consent to the processing of personal data is sent to the following email address: mail@lavicon.ru , as well as by writing to the legal address: 352830, Krasnodar Territory, M.O. 2.2. The Site processes the User's personal information for the following purposes:

2.2.1. Identification of the User who left the request on the Website.

2.2.2. Establishing feedback with the User, including referral notifications, requests regarding the use of the Site, provision of services, processing of requests and requests from the User.

2.2.3. Creating an account for booking on the Website, if the User has agreed to create an account.

2.2.4. Notifying the Website User about the confirmation of personal data processing.

2.2.5. Providing the User with effective customer and technical support in case of problems related to the use of the Site.

2.2.6. Carrying out advertising activities with the User's consent.

3. CONDITIONS OF PERSONAL INFORMATION PROCESSING

USERS AND ITS TRANSFER TO THIRD PARTIES

3.1. The Website stores Users' personal information in accordance with the internal regulations of specific services.

3.2. With respect to the User's personal information, its confidentiality is maintained, except in cases where the User voluntarily provides information about himself for general access to an unlimited number of persons. When using certain services, the User agrees that a certain part of his personal information becomes publicly available.

3.3. The Website has the right to transfer the User's personal information to third parties.

in the following cases:

3.3.1. The User has consented to such actions.

3.3.2. The transfer is necessary for the User to use a certain service or to fulfill a certain agreement or contract with the User.

3.3.3. The transfer is provided for by Russian or other applicable legislation within the framework of the procedure established by law.

3.3.4. In case of sale of the Website, all obligations to comply with the terms of this Policy in relation to the personal information received by the buyer are transferred to the buyer.

3.4. The User's personal data is processed without time limit in the following ways: collection, recording, systematization, accumulation, storage, clarification (updating, modification), extraction, use, transfer (distribution, provision, access), depersonalization, blocking, deletion, destruction of personal data, including in personal data information systems with or without the use of automation tools. The processing of personal data of Users is carried out in accordance with Federal Law No. 152-ФЗ of 27.07.2006 "On Personal Data".

3.5. In case of loss or disclosure of personal data, the Website Administration informs the User about the loss or disclosure of personal data.

3.6. The Site Administration takes the necessary organizational and technical measures to protect the User's personal information from unauthorized or accidental access, destruction, modification, blocking, copying, distribution, as well as from other illegal actions of third parties.

3.7. The Site Administration, together with the User, takes all necessary measures to prevent losses or other negative consequences caused by the loss or disclosure of the User's personal data.

4. OBLIGATIONS OF THE PARTIES

4.1. The User is obliged to:

4.1.1. Provide information about personal data necessary for using the Website.

4.1.2. Update and supplement the information provided about personal data in case of changes to this information.

4.2. The Site Administration is obliged to:

4.2.1. Use the information received exclusively for the purposes specified in this Privacy Policy.

4.2.2. Ensure that confidential information is kept confidential, not disclosed without the User's prior written permission, and not sold, exchanged, published, or otherwise disclosed by the User's personal data, except as provided for in this Privacy Policy.

4.2.3. In order to ensure the protection of the User's personal data during processing, the following legal, organizational and technical measures have been taken against unauthorized, unlawful or accidental access to personal data, destruction, modification, blocking, copying, provision, dissemination of personal data, as well as other unlawful actions with respect to the personal data of the User of the Site.

4.2.4. To block personal data related to the relevant User from the moment of the request or request of the User or his legal representative or the authorized body for the protection of the rights of personal data subjects for the verification period in case of identification of false personal data or illegal actions.

5. RESPONSIBILITY OF THE PARTIES

5.1. The Site Administration, which has not fulfilled its obligations, is responsible for losses incurred by the User in connection with the misuse of personal data, in accordance with the legislation of the Russian Federation.

5.2. In case of loss or disclosure of confidential information The Site Administration is not responsible if this confidential information is:

5.2.1. Became public domain before its loss or disclosure.

5.2.2. It was received from a third party before it was received by the Administration The site.

5.2.3. It was disclosed with the User's consent.

6. DISPUTE RESOLUTION

6.1. Before applying to the court for disputes arising from the relationship between By the Site User and the Site Administration, it is mandatory to submit a claim (a written proposal for a voluntary settlement of the dispute).

6.2. The recipient of the claim shall, within 10 (Ten) calendar days from the date of receipt of the claim, notify the claimant in writing of the results of the claim review.

6.3. If an agreement is not reached, the dispute will be referred to the court in accordance with the current legislation of the Russian Federation.

6.4. To this Privacy Policy and the relationship between The current legislation is applied by the User and the Site Administration. Of the Russian Federation.

7. ADDITIONAL TERMS AND CONDITIONS

7.1. The Site Administration has the right to make changes to this Privacy Policy without the User's consent.

7.2. The new Privacy Policy comes into force from the moment it is posted on the Website, unless otherwise provided by the new version of the Privacy Policy.
